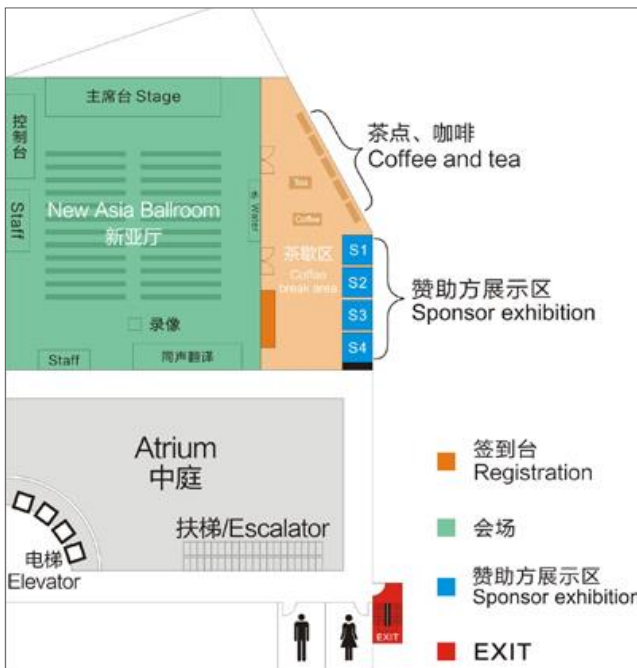
The closest Metro Station is Century Ave Station. You can arrive at this station by M2, M4, M6 or M9 of Shanghai Metro.
